Religious Order

- > This nomination is aimed at recognizing the order for their service to our schools.
- ➤ One order per year will be recognized.

Friend of Catholic Education (clergy, diocesan leader, active supporter)

- Many people support our schools through their work to advance Catholic education.
- ➤ One person will be recognized in this category each year.

Service to Catholic Education

- Individuals who have spent their careers in Catholic education.
- ➤ 25+ Years
- ➤ Not currently in Catholic school leadership
- ➤ Recently retired school leader
- ➤ One person will be recognized in this category each year.

Spark award (less than 3 years' service)

Encouraging those new to Catholic school leadership who are already making their mark.

Additional criteria for all categories

- ➤ Displays a commitment to excellence, as evidenced by programs designed to meet the spiritual, academic, and social-emotional needs of all students and teachers.
- > The school where the administrator is employed or has recently retired is a member of the Catholic School Administrators Association of New York State.
- ➤ Has a clear philosophy of Catholic education.
- > Shows a strong commitment to leadership through active membership in professional associations.
- ➤ Is respected by students, colleagues, parents, and the community at large.
- ➤ Shows strong educational leadership by setting high expectations for school staff and students.

Evidence of outstanding contributions to the well-being of the educational community includes:

- > Ways in which the nominee's leadership has benefited Catholic education, curriculum, staff morale, community support, student interest, and /or the learning environment.
- > Ways in which the nominee provides creative leadership to inspire others to achieve and contribute to their Catholic education communities.
- **Examples** of service or achievements above and beyond what is expected.
- Ways in which others have acknowledged the nominee as a force for positive change.
